

# 2025 Cactus Reining Classic Terms & Conditions

## STABLING

Stalls will be available starting at **6:00PM Wednesday, March 12, 2025** at a fee of \$425 per stall, each stall includes 6 bags of white pine shavings. Shavings provided will be locked inside each stall upon arrival. **Additional shavings and/or feed must be ordered through WestWorld Feed & Bedding Office (480) 312-6814 or use their online ordering at [www.westworldaz.com](http://www.westworldaz.com) by 3:00PM** for same day delivery. Priority stall placement is given to event sponsors. Stalls can be ordered on the event website [www.brumleyevents.com](http://www.brumleyevents.com) ONLINE ONLY - Stall reservation deadline is **March 1, 2025**. Stalls ordered after this date are considered late orders and will be assessed an additional \$20 per stall. We highly recommend you get your stall orders in early so that we can make sure we get your group together. Stalls may sell out and are not guaranteed. No stall refunds after March 5. If you need a refund please email a request to [bmgstalls@gmail.com](mailto:bmgstalls@gmail.com), with stall refund in the subject line. For all refunds, a \$20 administration will be charged per stall.

## DAY HAUL IN

Exhibitors are allowed to haul into the event and tie to their trailers in designated parking areas only. There is a fee of \$25 per horse, per day to haul into the event. Parking in undesignated parking areas will subject to \$100 fine per occurrence.

## DAMAGE

Individuals will be responsible for any physical damage inflicted to the WestWorld of Scottsdale property and will reimburse the show management for such damage as it may be charged. All owners and exhibitors shall be responsible for any damage incurred by them, their agents or employees to stalls, buildings, and other properties on the show grounds and shall be billed accordingly.

## PHOTOGRAPHY AND VIDEO

No outside video or photography is allowed. Competitors are encouraged to purchase videos and photos from the official show cinematographer and images from the official photographer. By way of entry into the event, competitors, and their respective employees, agents and family members grant the permission without remuneration for the use and public distribution of their image, likeness, voice and video for promotion of the event. All exhibitors will be subject to the use of photographers and cinematographers under the direction of show management for the benefit of show promotion. No exhibitor will be allowed the discretionary use of his or her services. **ONLY THE OFFICIAL EVENT PHOTOGRAPHER WILL BE ALLOWED TO SELL PHOTOGRAPHS OF THE CACTUS REINING CLASSIC HORSE SHOW.** All images pertaining to or in relation to the Cactus Reining Classic Horse Show are under the sole ownership of Brumley Management Group. Only reporters assigned by recognized newspapers, radio or television or the Associated Press will be issued press passes. Requests for press passes MUST be sent in writing, e-mailed to [brumleyevents@gmail.com](mailto:brumleyevents@gmail.com), on the letterhead of the newspaper, magazine or broadcast outlet and signed by the editor. All other photographers must sign an agreement not to sell their photographs except to the publications for which they work two weeks prior to the beginning of the show. Photographers and camera crews who have not followed these requirements will be escorted off the grounds.

The event taking place in this area (WestWorld of Scottsdale) is being videotaped/recorded for a Truly Original, LLC ("Company") program currently entitled "The Last Cowboy" (the "Series"). By entering this competition you hereby irrevocably grant to Company and its affiliates and assigns (including without limitation event and program sponsors, advertisers, and marketing partners) the right to photograph your image and record your voice, and to own, license, assign and/or use the same (and/or any portion thereof) forever and throughout the world in any manner and/or medium including, without limitation, in Company and other sponsored or unsponsored programming and the advertisement and promotion thereof. You will not receive any payment for such use and waive any right to bring any action in law or equity against Company, its parent and related companies, subsidiaries (whether or not wholly-owned), affiliates, divisions, and their past, present and future officers, agents, representatives, employees, successors and assigns for such use.

In view of the fact that my participation in the event will bring me into close contact with many confidential elements of the Series not readily available to the public, and disclosure thereof will eliminate the surprise of the Series for the viewing public, Exhibitor agrees to keep and retain in the strictest confidence all information he/she receives as competitor concerning or relating to the Series. Exhibitor's confidentiality obligations hereunder shall apply to any and all media whatsoever, including, without limitation, any social media or any other website, service, platform, program, application or other form or method of communication, whether now known or hereinafter devised. For example and for the sake of clarity, Exhibitor may not make disclosures prohibited hereunder via Facebook, Twitter, YouTube or any other similar website or service, whether existing now or in the future.

By making an entry into this event Exhibitor acknowledges that in the event that he/she breaches this confidentiality, Company shall be entitled to seek any remedy available at law and I further agree to pay Competitor the sum of One Million Dollars (\$1,000,000.00) as liquidated damages.

## HEALTH REQUIREMENTS & CERTIFICATES

Health requirements for the State of Arizona will be followed. **Out of State Horses:** owners/agents are required to present a 30-day ORIGINAL health certificate, and 12-month Coggins. **Horses Residing in Arizona:** owners/agents are required to present a 12-month Coggins. Make sure horse registration name is listed on the paperwork. Papers are required to be presented to the show office at check in.

## LIABILITY

By participating in the Cactus Reining Classic, all competitors agree to abide by the terms and conditions of the show and the governing body NRHA. In addition, acknowledge that horses are dangerous animals and can be hazardous. By participating in the competition with this knowledge of the danger involved the competitor agrees to accept any and all risks of injury or death. A Release of Liability must be signed by every exhibitor participating in the competition prior to receiving their entry number.

## RULES/CHANGES

The Cactus Reining Classic, and Brumley Management Group Inc., reserve the right to make additions or changes to this event at any time. Show management has the authority to enforce all terms and conditions referring to the show and may excuse any horse or exhibitor from the show prior to, during or after the judging without refunds. The show management reserves the right to interpret these terms and conditions. All decisions are final. By way of making an entry, the exhibitor is assuming responsibility for knowledge of these terms and conditions and releases show management from any claims or losses. The show management reserves the right to modify or change the terms and conditions for the Cactus Reining Classic event at any time. All decisions of the judges are final.

## **RIGHT TO CANCEL**

The show management reserves the right to cancel the event without notice at any time prior to the contest and without liability to the show management. In the event of such cancellation, entry fees or other show fees paid in advance shall be refunded. The show management reserves the right to itself to interpret all questions and conditions in regard to, or arising out of, or incident to, the show without claims for damages or recourse of any kind. All questions not covered in these terms and conditions shall be decided by show management, its decision to be final. **SHOW MANAGEMENT RESERVES TO ITSELF THE RIGHT TO REFUSE, ACCEPT CONDITIONALLY, OR TO CANCEL ANY ENTRIES, DISQUALIFY ANY RIDERS OR EXHIBITORS, PROHIBIT EXHIBITION OF ENTRIES AND CANCEL OR CHANGE AWARD PRIZES, WITHOUT CLAIM OF DAMAGES.** Every horse entered herein for competition will be under control of the show management, but the show management will in no case be responsible for any theft, loss or damage that may occur and it shall be a condition of entry that each exhibitor shall hold Cactus Reining Classic, Brumley Management Group, Inc. officials, employees, Directors, Sponsors and the West World, City of Scottsdale and Bureau of Reclamation blameless for any loss or accident to horse(s), family members, employees, or equipment.

## **SECURITY AND PARKING**

WestWorld of Scottsdale does not provide security in any areas of the facility. Cactus Reining Classic does not supply security. Neither WestWorld of Scottsdale, Cactus Reining Classic, nor Brumley Management Group, Inc. are responsible for damaged, lost or stolen items. There are designated areas to park cars, trucks and trailers. It is required that all trailers be parked in designated parking areas only. Parking in undesignated parking areas will subject to \$100 fine per occurrence. Sponsor parking areas are designated for event sponsors only. All other vehicles are subject to fines and towing for parking in designated sponsor parking areas without showing parking passes.

## **DISCIPLINARY PROCEDURES**

**FAILURE TO PAY:** Any fees associated with the entry of a horse in the Cactus Reining Classic, including but not limited to entry fees, administrative fees, stall fees, sponsorships, etc. which are not paid in full within 15 days of the close of the event will result in owner of horse or sponsor's immediate suspension from competing in or participating in any further Brumley Management Group, Inc events until amount owed and any late and/or NSF fees are paid in full.

**BEHAVIOR, CONDUCT AND ANIMAL WELFARE:** Any action of disrespect, deceit, slander or fraud directed to the event, show management, grounds crew, show representatives, sponsors or judges will result in disqualification from competition and removal from the facility. No entry, administrative fees or stall refunds will be provided. Individuals accused of unsportsmanlike conduct will be subject to the disciplinary procedures set forth by the National Reining Horse Association in Article A of the handbook. Anyone found to be abusing animals will be disqualified and reported to NRHA. **IN ADDITION, THESE INDIVIDUALS WILL BE SUSPENDED FROM PARTICIPATING IN ANY BRUMLEY MANAGEMENT GROUP, INC (BMG) EVENTS FOR A MINIMUM OF ONE YEAR.** Reinstatement of the right to exhibit is based on review by BMG production and show management.

## **SCHOOLING HORSES DURING COMPETITION CONDITIONS**

**Every competition class offered at this event is broadcast LIVE over the internet to the WORLD.** In an effort to maintain the integrity and professional appearance of the event, all exhibitors choosing to enter COMPETITION CLASSES to school horses, MUST present these horses in show attire. Show attire is defined as; exhibitor's entry is required to present their horse with a show pad, clean tack, and the horse's tail must be down (not braided or up in a tail bag/sock). It is requested by show management that the rider wear show chaps. As per NRHA Attire Guidelines, a long sleeve shirt, western hat and boots are required. The Gate Steward at the in-gate will enforce this guideline. Any exhibitor refusing to follow this protocol will be declined access to the arena and subject to disciplinary unsportsmanlike conduct procedures.

**OPEN SHOW TABS:** Will be held in the show office. An open check or credit card authorization form for each horse entered will be required to pick up competitor numbers. Checks not closed out within one hour after the end of the last class of the event will be closed out according to the responsible party's account and will incur a \$20 service fee. **Trainers will be responsible for all client fees not paid at the close of show and therefore will be applied to trainer's show bill.**

**PAID WARM UPS:** Paid warm ups must be ordered online via the event website and are non-refundable.

**DIVISION ADDS:** In the case of multiple divisions running concurrently, once the draw is posted no divisions may be added. It is the exhibitor's responsibility to confirm divisions entered prior to the draw taking place. In the case of an office error, division will be added prior to the start of the competition. It is the exhibitor's responsibility to notify the show office prior to the start of the competition if the divisions listed are incorrect or missing. Once competition has started no changes will be made.

## **CHANGING/ADDING CLASSES AT THE SHOW**

An entry change form must be filled out for all classes being entered through the office at the show. **NO CHANGES WILL BE TAKEN AT THE BACK GATE. NO REFUNDS OF ANY ENTRY FEES ONCE THE CLASS DRAW HAS BEEN POSTED.**

## **FEES**

Each horse entered in the event will be assessed a one-time Administration Fee of \$85.00, a one-time Photography Fee of \$25.00, Video Fee of \$25.00, and \$35.00 NRHA Drug Fee –NRHA approved classes only. Exhibitors who do not check out their accounts prior to their departure will be charge a one-time fee close out fee of \$20. Returned checks or declined credit cards will be charge a \$50 NSF Fee. Remaining balances will have 10 days to provide payment in full via cashier's check or credit card (including credit card fee of 4%). Payments not received within the designated time may incur penalty fees.

## **NRHA DIVISION PRIZE MONEY**

See the NRHA rulebook for purse calculation and purse distribution. Please use reinersuite to confirm which payout schedule is being used.

## **PAYEE**

Prize money will be paid to the owner of the horse as recorded on the NRHA Competition License, unless requested in writing to be paid to another entity.

## **AWARD PAYOUT CHECKS**

Payouts will not be mailed out without the proper EIN or Social Security Number of Payee. It is the exhibitor's responsibility to provide the show office with all pertinent tax information. Payouts will be mailed once management receives NRHA approval of results. If NRHA does not return approved results to show management within 30 days after the last day of the event, checks will be mailed out to abide by NRHA's 30 day payout rule requirement. If checks are mailed out prior to show management receiving NRHA result approval, Cactus Reining Classic and Brumley Management Group, Inc. will not be held liable for any prize money or awards not returned to show management by those who are disqualified by NRHA. Those who fail to provide payment for outstanding invoices or return disqualified prize money within 10 days of being notified by NRHA, will be **SUSPENDED** from any further Brumley Management Group events and reported to the NRHA for disciplinary procedures. Any outstanding balances owed will be deducted from payouts.

## AWARDS

Exhibitors are responsible for picking up their awards at the event. Awards not picked up at the event will not be shipped. If the exhibitor contacts Brumley Management Group in writing requesting items to be shipped, cost of shipping, packaging and a \$25 service fee will must be paid by exhibitor prior to shipping.

## ARENA PROTOCOL

All riders must **IMMEDIATELY** exit the arena when the water truck enters the arena. When a tractor/drag enters an arena, all riders in the arena must move to one side of the arena. Once at the side of the arena, riders must cease all motion (including walking, spinning, trotting circles, backing, etc.). Failure to comply will result in all horses being excused from the arena to complete the drag.

## ENTRY INFORMATION

### **ALL ENTRIES MUST BE RECEIVED BY MARCH 1, 2025**

**Submission of ONLINE entry must be completed by March 1, to avoid post registration fees. Credit Card Authorization must be provided to enter. If exhibitor would prefer to pay by check, a check may be brought to the show office prior to the last day of the event.**

**AMATEUR DERBY:** For horses four, five, six and seven years of age as of the start of the calendar year. To compete in the Amateur division, the same horse and rider must be cross-entered into the NRHA-approved non pro derby. The show conditions will govern which level or levels must be entered.

The criteria are as follows:

The following riders are **excluded** from competing in the Amateur division:

- Youth (as defined by the youth membership requirements in the NRHA Handbook).
- Legal dependents of professional equine trainers. A legal dependent is defined as being officially claimed as a dependent on a tax return.
- Spouses or legal partners/mates of professional equine trainers. Partner/mate status will only be accepted when the civil status is legally and lawfully registered in the country/state of residence. All relationships must be current and lawful. A "professional equine trainer" is defined as someone who handles the mounted preparation of a horse with the intent to improve the horse's performance in any equine discipline (as defined in the NRHA Handbook).
- Anyone who has exceeded NRHA lifetime earnings of \$100,000 in Categories 2, 6, 8, and 11 as of the previous year or is currently eligible for L4 Non Pro only or L4 and L3 only.

## DERBY DIVISIONS PRE-REGISTRATION:

Derby divisions are offered for horses that are four (4), five (5), six (6), or seven (7) years of age as of the start of the calendar year. Horses may be shown one handed in a legal bridle or two handed in a snaffle or hackamore. **RIDERS MUST LEVEL UP ONE DIVISION BUT ARE NOT REQUIRED TO ENTER LEVEL 4.**

## WILD CARD DIVISIONS PRE-REGISTRATION:

Wild Card is a division offered for horses that are four (4) years of age as of the start of the calendar year. Horses cannot have won in excess of \$7,500 in life time earnings.. Horses may be shown one handed in a legal bridle or two handed in a snaffle or hackamore. **RIDERS MUST LEVEL UP ONE DIVISION BUT ARE NOT REQUIRED TO ENTER LEVEL 4.**

## THE RUN FOR A MILLION – MILLION DOLLAR COMPETITION QUALIFIER CONDITIONS (Entries must be **received** by March 1)

NRHA Ancillary Category 1 - \$20,000 Added Open Division will run concurrent with the Open Derby divisions, March 22, 2025 at WestWorld of Scottsdale. This division is being offered as the Million Dollar Competition Qualifier for The Run For A Million 2025. The top ten placings will join the riders who already qualified at the 2024 Run For A Million Open Shootout, and 2023 Equita Lyon Qualifier, to compete for \$1,000,000 in prize money. **In the case of ties for tenth place, exhibitors will be required to run off for 10<sup>th</sup> place. Riders not willing to run off will forfeit their placing.**

## **CACTUS REINING CLASSIC MILLION DOLLAR QUALIFIER NOTIFICATION OF DRUG TESTING - NOTICE TO EXHIBITORS**

**The Run For A Million – Million Dollar Competition Qualifier, hosted by the Cactus Reining Classic, Saturday, March 22, 2025 at WestWorld of Scottsdale.**

**During the course of the competition, horses landing in top ten status will have blood samples drawn by a licensed veterinarian for testing for illegal substances as defined in the rules of the National Reining Horse Association Handbook. This includes, but is not limited to, all forms of tranquilizing agents including ROMIFIDINE, or any generic version of. Tests will be submitted by licensed veterinarian to the NRHA designated lab testing facility. Any horse, found with illegal substances or legal medications outside the defined limits, will be disqualified. If a rider's horse tests positive there will be no substitutions for disqualified horses and the rider will not be able to compete in the 2025 TRFAM Competition.**

**LATE ENTRIES** Late entries will be accepted with the following late fees:

**GED EVENT AND TRFAM MILLION DOLLAR QUALIFIER ENTRIES** Received after March 1 - \$200 one-time late fee assessed, plus all entry fees payable at the time of entry.

**ANCILLARY AND RANCH SUPER HORSE ENTRIES** Received after March 1 - \$85 one-time late fee assessed, plus all entry fees payable at the time of entry.

**DRAGS:** All Aged Event competition will have a drag after every six (6) horses on paper. The drag **WILL NOT** be moved due to scratches.

## THE RUN FOR A MILLION – ROOKIE 1 & 2, YOUTH, AMATEUR & NON PRO CHAMPIONSHIP QUALIFIER CONDITIONS

### ROOKIE 1 CHAMPIONSHIP, ROOKIE 2 CHAMPIONSHIP, YOUTH CHAMPIONSHIP, AMATEUR CHAMPIONSHIP, NON PRO CHAMPIONSHIP

The Rookie 1, Rookie 2, Unrestricted Youth, Amateur\*, and Non Pro qualifying classes will run concurrent with NRHA Rookie 1 & 2, Youth and Ancillary Non Pro divisions. Exhibitors are required to enter into the corresponding NRHA division to be eligible for The Run For A Million (TRFAM) Qualifier. Exhibitors who qualify in the first slate but are still entered in the second slate will be automatically taken out of the second slate. Top five, and ties qualify to compete at TRFAM, Las Vegas.

There is an entry fee for each qualifying division of \$250. There are no prizes or payouts offered. The entry fees have been established to ensure those who are committed to wanting to take part in TRFAM Championship divisions have the opportunity to do so without the possibility of being knocked out of a spot by another exhibitor who does not wish to, or cannot participate in TRFAM. Riders can only qualify one-time per division (Rookie, Non-Pro, Youth and Amateur) and qualification is based on rider not the horse.

### **There are only three events offering Youth and Amateur Qualifiers in 2025:**

EASTERN: FLORIDA REINING CLASSIC, February 2025

WESTERN: CACTUS REINING CLASSIC, March 2025

CENTRAL: NATIONAL REINING BREEDERS CLASSIC, April 2025

### TRFAM AMATEUR CHAMPIONSHIP DIVISION ELIGIBILITY\*

The following riders are **excluded** from competing in TRFAM Amateur Championship Qualifier:

- Youth (as defined by the youth membership requirements in the NRHA Handbook).
- Legal dependents of professional equine trainers. A legal dependent is defined as being officially claimed as a dependent on a tax return.
- Direct Family: Spouses or legal partners/mates of professional equine trainers. Partner/mate status will only be accepted when the civil status is legally and lawfully registered in the country/state of residence. All relationships must be current and lawful. A "professional equine trainer" is defined as someone who handles the mounted preparation of a horse with the intent to improve the horse's performance in any equine discipline (as defined in the NRHA Handbook).
- Anyone who has exceeded NRHA lifetime earnings of \$100,000 in all NRHA categories.
- NRHA judges are eligible to compete in the Amateur Qualifier if they meet the required criteria listed above.

### ENTRY DIVISION PRE-REGISTRATION: (Entries must be **received** by March 1)

Submission of completed Entry Form, one per horse, NRHA Competition License and Owner/Rider current NRHA Membership cards, and signed Participation Liability Release must be **received** by March 1, for entry to be considered complete and avoid the \$85 Post Registration Fee. A form of payment will be required at check-in and to receive your number at the show office. **HORSES MUST BE SHOWN ONE HANDED IN ANY LEGAL BRIDLE.**

## RANCH SUPER HORSE

Ranch Super Horse is not affiliated with any breed association, so all breeds are welcome, and no association memberships are required. There are three components of competition; **Ranch Riding, Ranch On The Rail, and Ranch Trail**. Exhibitors are limited to entering a maximum of three horses per division. Bridles will be checked at random by judges. Any use of illegal equipment will be immediately disqualified. No event reimbursements will be provided.

**RANCH SUPER HORSE PRIZE MONEY: \$10,000 SENIOR HORSE OPEN (Horses aged 6 and over), \$5,000 OPEN RANCH DERBY (4 & 5 year old horses), \$5,000 STAKES (4 Year Old horses), \$5,000 AMATEUR, No added money is being offered in the NOVICE AMATEUR and YOUTH ALL AGES DIVISION, SELECT AMATEUR WILL BE JACKPOTTED**

### ENTRY FEES:

- SENIOR HORSE OPEN - \$1000
- OPEN DERBY - \$500
- STAKES - \$500
- AMATEUR - \$500
- SELECT AMATEUR - \$100
- NOVICE AMATEUR - \$75
- YOUTH ALL AGES - \$50

**ONE ENTRY FEE PER DIVISION** (*entry fee enters all Ranch Super Horse divisions.*) 50% of the entry fee will be added back into the purse (for all classes except Youth and Novice Amateur) combined with the prize monies offered to determine the total payout for each division.

### HIGH POINT RANCH RIDING, RANCH ON THE RAIL AND RANCH TRAIL JUDGING SYSTEM

We will be using a three (3) judge system. The overall winner will be determined by assigning point values to the placings in each of the three divisions, starting with ten (10) for first place and ending with one (1) for tenth place. In the case of an overall tie for Ranch Super Horse Champion, the combined cumulative scores of judge one will break the tie. If there is still a tie, the combined cumulative scores of judge two will break the tie. In the instance there is still a tie for Champion, the tied riders will have a work-off in the Ranch Trail to determine the Champion.

### RANCH SUPER HORSE PRIZES:

Custom Trophy Buckles will be presented to the TOP FIVE winning places in each overall division. Daily division prizes will be awarded for first through sixth place.

### RANCH SUPER HORSE DIVISIONS ELIGIBILITY

Updated 2/7/25 at 10:53 am

- **SENIOR HORSE OPEN:** All individuals are eligible for this division. Horses must be six years of age or older as of the start of the calendar year. A copy of breed association registration papers must be provided with entry. **HORSES MUST BE SHOWN ONE HANDED IN ANY LEGAL BRIDLE, OR TWO REIN.**
- **OPEN DERBY:** All individuals are eligible for this division. Horses must be four or five years of age as of the start of the calendar year. A copy of breed association registration papers must be provided with entry. **HORSES MAY BE SHOWN ONE HANDED IN A SNAFFLE BIT, HACKAMORE, ONE HANDED IN ANY LEGAL BRIDLE, OR TWO REIN.**
- **OPEN STAKES:** All individuals are eligible for this division. Horses must be four years of age as of the start of the calendar year. A copy of breed association registration papers must be provided with entry. **HORSES MAY BE SHOWN ONE HANDED IN A SNAFFLE BIT, HACKAMORE, ONE HANDED IN ANY LEGAL BRIDLE, OR TWO REIN.**
- **AMATEUR:** All non-professional individuals are eligible for this division. A copy of Amateur or Non Professional current membership card from any association must be provided for entry. The horse must be owned by the exhibitor or direct family\* or on documented lease through an accredited association such as AQHA, APHA or NRHA. Lease papers must be provided for entry. **HORSES MUST BE SHOWN ONE HANDED IN ANY LEGAL BRIDLE.**
- **SELECT AMATEUR:** To be eligible for the Select Amateur division an individual must be fifty years of age as of the start of the calendar year, and cannot have received financial compensation for training a horse astride, showing someone else's horse or providing riding instruction. A copy of Select Amateur or Non Professional current membership card from any association must be provided for entry. The horse must be owned by the exhibitor or direct family\* or on documented lease through an accredited association such as AQHA, APHA or NRHA. Lease papers must be provided for entry. **HORSES MUST BE SHOWN ONE HANDED IN ANY LEGAL BRIDLE.**
- **NOVICE AMATEUR:** To be eligible for the Novice Amateur an individual cannot have received financial compensation for training a horse astride, showing someone else's horse or providing riding instruction. Cannot have earned \$25,000 in lifetime earnings showing a horse astride or have earned 25 points in any breed association. A copy of Amateur or Non Professional current membership card from any association must be provided for entry. Exhibitor **MAY** show a horse not owned by the exhibitor or direct family member. **HORSES MUST BE SHOWN ONE HANDED IN ANY LEGAL BRIDLE.**
- **YOUTH ALL AGES:** To be eligible for the Youth All Ages an individual must be 18 years old or younger as of the start of the calendar year. A copy of Youth current membership card from any association must be provided for entry. Exhibitor **MAY** show a horse not owned by the exhibitor or direct family member. **HORSES MUST BE SHOWN ONE HANDED IN ANY LEGAL BRIDLE.**

*\*Direct family by definition: Spouses or legal partners, son or daughter, grandfather or grandmother.*

#### **RANCH ON THE RAIL**

The Ranch On The Rail will be divided into multiple sections, with a maximum of twenty horses per section. If an exhibitor wishes to compete on more than one horse, these horses will be separated into different sections for this division. Three judges will place each section, using the designated point system. The combined scores will determine those who advance to the final from each section. The top five and ties for fifth, will be brought back for a final that will determine the overall winner. If the same rider has more than one horse make it back to the final, a catch rider may be used. Each judge will place the riders by assigned a point value starting with (10) for first place and ending with (1) for tenth place. These values will be added together to determine division placing.
